I do voluntarily release, indemnify, hold harmless and discharge Fill It With Fun, Inc., from any and all liability, claims, demands, actions or rights of actions whether personal to me or to a third party which are related to arise out of or in any way connected with me renting an inflatable unit(s) those allegedly attributable to neglect acts or omissions. I agree to reimburse any reasonable attorney fees and costs which may be incurred by Fill It With Fun, Inc. in the defense of any such liability claim demand, action or right of action. In the event that I file a lawsuit against Fill It With Fun, Inc., I agree that the substantive law of the state may apply in the action without regard to the conflict of the law of the state.

2. The risk of injury from this equipment can be significant, including the potential for paralysis and even death and while particular rules, equipment and safety discipline reduce the risk, the risk does exist.

I, for myself and behalf of my heirs, assign, personal representative and next of kin, hereby hold harmless Fill It With Fun, Inc. and their officers, agents, employees other participants, and sponsoring agencies with respect to any or all injury, disability, death, or loss of damage to personal or property to the fullest extent of the law.

Safety Rules & Rental Agreement

Specific rules to follow:

1. Compatible age groups must play on the inflatable unit at the same time. Age groups must NOT be mixed. Different size children must NOT be mixed.
2. The maximum number of children in the inflatable jump house:

Ages 1 to 5 years old, 8 children

Ages 6 to 11 years old, 6 children

Ages 12 to 17 years old, 4 children

1. All persons must remove shoes, glasses, jewelry, belts, sharp objects, and anything else that might harm the inflatable unit.
2. No flips or somersaults.
3. All persons on water slides must wear a swim suit and slide feet first.
4. All persons on the water slides must NOT climb up or on the slide in an inappropriate manner, everyone MUST use the ladder.
5. No food, candy or drinks inside or near the inflatable unit. (within 15 feet)
6. Do not cut plastic ties or anything on the inflatable unit.
7. Do not tape or fasten anything to the inflatable unit.
8. Children/guests must be supervised at ALL times. Please read the list of rules to ALL guests using the inflatable unit.
9. When unit is used with water, it is the responsibility to make sure that the water is turned off, the fan on and that the unit is still inflated when the Fill It with Fun representative arrives after the event. (for at least 1 hour)
10. If rules are not followed when using water, customer is subject to additional fee.

Should the inflatable unit begin to deflate?

1. Remove all persons from the inflatable unit.
2. The motor has stopped: check the cord connection at the outlet and the blower.

3. The blower continues to run: check the air intake on the side of the blower for any blockage. Check the inflatable tube to the blower for snugness and pull the strap for tightening if necessary.
